SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS

This product contains the following components and mixture of the following substances with non-hazardous additions.

ABTS Reagent: 20 mL Liquid

Contains 0.1-1% 2,2'-Azino-bis(3-ethylbenzothiazoline-6-sulfonic acid) diammonium salt (CAS#: 30931-67-0).

3% H₂O₂: 20 μL Liquid Contains 3% Hydrogen peroxide (CAS #: 7722-84-1) HRP: 100 μL Liquid Non-hazardous Trolox Standard: 100 μL Liquid Non-hazardous

SECTION 4. FIRST AID MEASURES

Eye: Eye irritation. Flush immediately with large amounts of water for at least 15 minutes. Eyelids should be held away from the eyeball to ensure thorough rinsing. Get immediate medical attention.
