SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS

This product contains the following components and mixture of the following substances with non-hazardous additions.

Assay Buffer: 10 mL liquid. Non-hazardous Enzyme A: 120 µL liquid. Non-hazardous.

Enzyme B: 120 µL liquid.

Non-hazardous NAD/MTT: 1mL liquid.

Contains 1-10% Thiazolyl Blue Tetrazolium Bromide (CAS#: 298-93-1). Standard: 100 µL liquid.

Contains 18% Acetaldehyde ammonia trimer (CAS#: 58052-80-5).

SECTION 4. FIRST AID MEASURES

Eye: Eye irritation. Flush immediately with large amounts of water for at least 15 minutes. Evelids should be held away from the eveball to ensure thorough rinsing. Get immediate medical attention.

Skin: Itching or burning of the skin. Immediately flush the skin with plenty of water while removing contaminated clothing and shoes. Get immediate medical attention. Wash contaminated clothing before reuse.

Inhalation: Remove exposed person from source of exposure to fresh air. If not breathing, clear airway and start cardiopulmonary resuscitation (CPR). Avoid mouth-to-mouth resuscitation.
