SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS

This product contains the following components and mixture of the following substances with non-hazardous additions.

Developer: 5 mL Liquid

Contains 0.5-2.0% potassium phosphate (CAS #: 16788-57-1) and 10-15% glycerol (CAS #: 56-81-5).

Enzyme Mix: 100 µL Liquid

Contains 0.5-2.0% potassium phosphate (CAS #: 16788-57-1) and Trehalose (CAS# 99-20-7)

Dye Reagent: 120 µL Liquid

Contains 90-99% dimethyl sulfoxide (CAS#: 67-68-5).

CoSubstrate: 100 µL Liquid

Contains 0.5-2.0% potassium phosphate (CAS #: 16788-57-1).

Standard: 100 µL Liquid

Contains 0.05-0.10% α -Ketoglutaric acid (CAS# 328-50-7).

SECTION 4. FIRST AID MEASURES

Eye: Eye irritation. Flush immediately with large amounts of water for at least 15 minutes. Eyelids should be held away from the eyeball to ensure thorough rinsing. Get immediate medical attention.
